The Village Garden Club of Sewickley Road Rally

Liability Waiver

September 24, 2022

The 2022 Village Garden Club of Sewickley Road Rally, hereinafter “Rally” is hosted by The Village Garden Club of Sewickley a 501(c)(3) charitable organization and a member (affiliate) of the Garden Club of America.

Personal transportation and car shipment to the event is totally my responsibility and following the close of the event to my next destination are solely my responsibility. Transportation along the course of the event is solely my responsibility.

The Rally conducts a road rally for motor vehicles. Operating motor vehicles, whether owned or leased or borrowed by me on roads and highways while participating in the event may be hazardous and may result in accident, loss, damage, injury or death, including personal property damage. I understand that by operating the motor vehicle or **riding therein**, I may sustain substantial risks and dangers, including but without limitation, auto accidents, animals on the road, forces of nature and/or lack of medical facilities in remote areas.

Operating a motor vehicle in violation of the traffic laws of any jurisdiction increases the substantial risks and dangers and the hazards that may result in in accident, loss, damage, injury or death, including personal or property damage to myself and others. Violating any motor vehicle law or laws is strictly against Rally policy and may result in my dismissal from the event without return of any portion of my event registration fee. I understand and agree that texting or other smart phone usage while operating a vehicle is not condoned by the Rally.

By signing this release and waiver, I hereby acknowledge and agree that I explicitly indemnify and release the Rally and The Village Garden Club of Sewickley, its officers, staff, organizers, volunteers, and board of directors, its insurance companies from any and all claims, suits, and penalties arising from any incident, mechanical failure, accident, injury, or loss of life involving, related to, or

resulting from my vehicle, whether such claims, or suits or penalties are brought by myself, my insurance company, or any third party.

I intend this release of liability to be effective whether or not any accident, loss, damage, injury, or death results from the negligence of the Rally or The Village Garden Club of Sewickley, or any of its representatives, agents, directors, officers, members, Rally coordinators, volunteers, servers, and fellow participants. I understand negligence means a failure to do an act which a reasonably prudent person would do, or that doing an act which a reasonably prudent person would not do, under the same or similar circumstances, to protect himself or herself, or others from accident, injury or death.

I agree to be solely liable and responsible for my own safety and to take every precaution to provide for my own safety and wellbeing while participating in activities sponsored or conducted by the Rally.
